It is forwarded for your information and subsequent action against our ex-employee Viz Noshad Ali Laghari S/o Karam Khan CNIC # 45206-5083509-9. Mob: 0305-2019100/0323-2286552

The subject employee was working with us as Deployment Officer for about 5 years.

During the tenure he indulged in fraudulent practice which was unfortunately revealed to us after a hiatus of about the same period.

The person had taken the following amount in cash from our various clients after signing their payment vouchers.

The amount he had taken as under:-

1. He had taken total amount of Rs. 1,210,825/=.
2. He had given to us Rs. 545,325/=.
3. The balance amount is Rs. 665,325/=.

He had promised to return the balance amount within three months – He gave this undertaking on stamp paper.

Afterward it was revealed that he has taken Rs. 695,258/= also from different clients.

Thus he owes us 665,325 + 695,258 total comes down to Rs. 1,360,583/=.

Later on we found out that the culprit has our stamp & letter head copies which he had been submitting to clients after taking cash from them.

Therefore you are requested to arrange recovery of stamp & original letter heads from him.
